### PRIVACY POLICY

# **Definitions and interpretation**

1. In this privacy policy, the following definitions are used:

Data	collectively all information that you submit to ROBBIE STAR ENTERTAINMENT via the Website. This definition incorporates, where applicable, the definitions provided in the Data Protection Laws;
Cookies	a small text file placed on your computer by this Website when you visit certain parts of the Website and/or when you use certain features of the Website. Details of the cookies used by this Website are set out in the clause below ( <b>Cookies</b> );
Data Protection Laws	any applicable law relating to the processing of personal Data, including but not limited to the GDPR, and any national implementing and supplementary laws, regulations and secondary legislation;

- 2. In this privacy policy, unless the context requires a different interpretation:
  - a. the singular includes the plural and vice versa;
  - b. references to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this privacy policy;
  - c. a reference to a person includes firms, companies, government entities, trusts and partnerships;
  - d. "including" is understood to mean "including without limitation";
  - e. reference to any statutory provision includes any modification or amendment of it;
  - f. the headings and sub-headings do not form part of this privacy policy.

### Scope of this privacy policy

- 3. This privacy policy applies only to the actions of ROBBIE STAR ENTERTAINMENT and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.
- 4. For purposes of the applicable Data Protection Laws, ROBBIE STAR ENTERTAINMENT is the "data controller". This means that ROBBIE STAR ENTERTAINMENT determines the purposes for which, and the manner in which, your Data is processed.

#### **Data collected**

- 5. We may collect the following Data, which includes personal Data, from you:

#### How we collect Data

- 6. We collect Data in the following ways:
  - a. data is given to us by you; and
  - **b.** data is collected automatically.

### Data that is given to us by you

- 7. ROBBIE STAR ENTERTAINMENT will collect your Data in a number of ways, for example:
  - **a.** when you contact us through the Website, by telephone, post, e-mail or through any other means;

# Data that is collected automatically

- 8. To the extent that you access the Website, we will collect your Data automatically, for example:

This information helps us to make improvements to Website content and navigation, and includes your IP address, the date, times and frequency with which you access the Website and the way you use and interact with its content.
  - **b.** we will collect your Data automatically via cookies, in line with the cookie settings on your browser. For more information about cookies, and how we use them on the Website, see the section below, headed "Cookies".

#### Our use of Data

- 9. Any or all of the above Data may be required by us from time to time in order to provide you with the best possible service and experience when using our Website. Specifically, Data may be used by us for the following reasons:
  - **a.** internal record keeping;
  - **b.** transmission by email of marketing materials that may be of interest to you;

in each case, in accordance with this privacy policy.

- 10. We may use your Data for the above purposes if we deem it necessary to do so for our legitimate interests. If you are not satisfied with this, you have the right to object in certain circumstances (see the section headed "Your rights" below).
- 11. For the delivery of direct marketing to you via e-mail, we'll need your consent, whether via an opt-in or soft-opt-in:

in each case, in accordance with this privacy policy.

## **Keeping Data secure**

- 14. We will use technical and organisational measures to safeguard your Data, for example:
  - **a.** access to your account is controlled by a password and a user name that is unique to you.
  - **b.** we store your Data on secure servers.
  - **c.** payment details are encrypted using SSL technology (typically you will see a lock icon or green address bar (or both) in your browser when we use this technology.

# Your rights

- 19. You have the following rights in relation to your Data:

If we provide you with access to the information we hold about you, we will not charge you for this, unless your request is "manifestly unfounded or excessive." Where we are legally permitted to do so, we may refuse your request. If we refuse your request, we will tell you the reasons why.
  - b. **Right to correct** the right to have your Data rectified if it is inaccurate or incomplete.
  - c. **Right to erase** the right to request that we delete or remove your Data from our systems.
